### LIMITED LIFETIME WARRANTY

Shutters239 warranties against defects in material and labor under conditions of normal use and regular maintenance. This warranty is effective from date of installation completion for repairs and/or replacements including parts and labor of items found defective. This warranty specifically covers products that exhibit defects during normal use. Shutters 239 does not guarantee or warrant products as 100% waterproof. **To maintain warranty validity, the product must undergo annual maintenance performed by our company, Shutters239, with all maintenance costs paid by the customer. Annual routine maintenance is the responsibility of the customer and is NOT INCLUDED in the warranty. All maintenance services must be scheduled and paid for by the customer each year.** Warranty claims are subject to the following fee schedule presented in the table below.

All screen products include a **lifetime motor warranty** and a **limited manufacturer's warranty of up to fifteen (15) years.** Warranty terms, coverage, and claim approval are subject to the manufacturer's policies. All **labor, service calls, adjustments, or repairs performed after installation**—including those related to warranty claims—are the **responsibility of the customer** and will be billed at Shutters239's standard service rates.

This warranty does not cover, and **becomes void** under the following circumstances:

- Damage resulting from fire, flood, wind, hurricane, or any other Act of God
- Damage caused by war, civil unrest, or similar events
- Any repairs, servicing, alterations, or modifications performed by a third party
- Misuse, abuse, neglect, or failure to follow maintenance guidelines

This warranty is the only warranty and replaces any others whether expressed or implied. This warrantor reserves the right to authorize the inspection, repairs and/or replacements of defective items by its appointed agent. Any equipment needed to get to the shutter...ie - Manlift, Scaffold, etc. will be the sole financial responsibility of the customer on all service calls performed under this warranty including regularly scheduled maintenance. Warranty is transferable, for the remainder of the warranty period, to new homeowners for an inspection and transfer fee of 4% of contract (inspection) and \$400.00 transfer fee payable by new homeowner.

### Warranty Transfer Limitation

**Shutters 239 reserves the right to deny** any request for warranty transfer if the product fails to pass a required company inspection. The warranty transfer will only be approved upon successful completion of this inspection, confirming that the product meets Shutters 239's standards for condition and proper care.
